We protected wildlife and wild places in many ways, including shaping public and political understanding and support for wildlife linkages Through participation in the Regional Transportation Authority and collaboration with the AZ Department of Transportations new Wildlife Connectivity Program, we advised and influenced land use planning and management to benefit native wildlife We helped secure funding for construction of several large wildlife crossing structures on state highways and federal interstates Underpass structures have been built and we are pushing for two more overpasses, nearby Construction of one wildlife overpass and one underpass will break ground later this year We continue to support public funding and future planning of smaller retrofit improvements to existing culverts and bridges to help wildlife like large colony bat boxes under urban highways We enhanced habitat for neotropical migratory birds including hummingbirds, warblers and the federally protected yellow-billed cuckoo on three major river systems in Sonora Through our partnership with the Instituto Tecnologico Superior de Cananea, dozens of Mexican students joined us to create wetlands and plant native riparian species We helped local landowners and communities fence cattle out of important riparian areas We led expeditions to Sierra Huerfana and Sierra Los Ajos, bringing together students and scientists from both countries to share their skills and passion for wildlife In conducting 10 wildlife tracking workshops and educational hikes, we trained 51 new volunteers and highlighted conservation efforts of our partner landowners or land managers A recent training in Sonora included 18 biologists representing 4 different National Parks and conservation agencies in Mexico, and 2 biologists from National Parks in the US In 2013, we completed a breakthrough project to protect springs Over two years, volunteers contributed 2,250 hours to help us survey 61 springs in the Cienega Creek Hydrogeologic Area With the information collected, we are improving restoration and protection of these ecosystems In cooperation with the Springs Stewardship Institute, we launched the online Springs Inventory Database for all to use This is a critical tool to improve understanding, protection, and restoration of springs This year, we discovered 11 new springs, collected important information about water quality, and identified plants and animals that rely on these oases
